ELECTION OF THE EXECUTIVE COMMITTEE OF THE INSURANCE ASSOCIATION OF PAKISTAN FOR THE YEAR 2022-2023

I am to inform members that scrutiny of Nomination Papers has been completed by the Election Commission. The names of the companies entitled to cast their vote at Karachi & Lahore have already been notified through Association's Circular C-7 of 25th August 2022. The members at **Lahore and Rawalpindi** will cast their vote at the Association's Regional Office North, at Lahore.

The election of members of the Executive Committee shall be held by **SECRET BALLOT**. The vote will be cast by the authorized representatives of a member who shall deposit with the Secretary General his Identity Card indicating his status in the Company.
