The changes, if any, regarding name of representative appearing in the list of voters' shall be intimated to the Secretary General of the Association along with necessary proof of eligibility within three days of the announcement of Elections Schedule.	Monday	8 th July 2024
The Secretary General shall display within seven days of the announcement of Elections Schedule the provisional list of all members eligible to vote.	Wednesday	10 th July 2024
The members who have any objection to the entries in the list of voters shall send their objections in writing to the Secretary General within seven days of the issuance of the voters' list.	Thursday	18 th July 2024
The Secretary General shall intimate action on the objections on list of voters within five days.	Monday	22 nd July, 2024
Any person aggrieved by the decision of the Secretary General may make a representation, within three days to the Election Commission which shall decide the representation within three days.	Tuesday	30 th July, 2024
Within three days of decision by the Election Commission or in case the Election Commission fails to decide within the stipulated time any person aggrieved by its decision may appeal to the Regulator who shall decide the appeal within ten days and his decision in this regard shall be final.	Monday	12 th August 2024
Within two days of the decision of the Regulator the final voters' list shall be issued.	Thursday	15 th August 2024
Within four days of the display of the final list of voters', any person who is eligible to contest the elections for the vacant post, shall send his nomination to the Secretary General duly	Wednesday	21 st August, 2024 (3:00 p.m.)

The objections, if any, to the nomination of the candidates may be filed to the Election Commission within twenty four hours of issuance of the list of candidates which shall be decided by the Election Commission within two days.	Monday	2 nd September, 2024
Any candidate aggrieved by the decision of the Election Commission may file an appeal to the Regulator within two days, who will decide the appeal within seven days and his decision in this regard will be final.	Friday	13 th September 2024
Within two days of the decision of the Regulator the Election Commission shall issue the final list of candidates.	Tuesday	17 th September 2024
Within five days of display of final list of candidates, the polling for election of Members of Executive Committee will be held.	Tuesday	23 rd September, 2024 (10:00 a.m. to 3:00 p.m.)
Within two days of the election, any person elected as Member of Executive Committee shall send his nomination for election as an Office Bearer (Chairman, Senior Vice Chairman and Vice Chairman) duly proposed and seconded by an elected Executive Committee member and signed by the candidate to the Election Commission.	Wednesday	25 th September, 2024 (3:00 p.m.)
The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed within twenty four hours of the last date of receipt of nomination papers.	Thursday	26 th September, 2024
Within two days of display of final list of candidates, the polling for election of Office Bearers (Chairman, Senior Vice Chairman and Vice Chairman) shall be held.	Friday	27 th September, 2024 (10:00 a.m. to 3:00 p.m.)
The final result shall be officially announced at the Annual General Meeting of the Association.	Saturday	28 th September, 2024 12:30 p.m.
