ELECTION OF THE EXECUTIVE COMMITTEE OF THE INSURANCE ASSOCIATION OF PAKISTAN FOR THE YEAR 2018-2019

I am to inform members that scrutiny of Nomination Papers has been completed by the Election Commission. The list of candidates for the Executive Committee who are eligible and are willing to serve on the Executive Committee is attached with this circular. Final List of Candidates will be issued on 18th September 2018.

As members are aware that the election of members of the Executive Committee for the year 2018-2019 shall take place on Monday, **24th September 2018**. The polling will be held at Association's Head office, Karachi and the Regional Office North, Lahore, from **10:00 A.M. to 3:00 P.M.**

The names of the companies entitled to cast their vote at Karachi & Lahore have already been notified through Association's Circular C-11 of 27th August 2018. The members at **Lahore and Rawalpindi** will cast their vote at the Association's Regional Office North, at Lahore.

The election of members of the Executive Committee shall be held by **SECRET BALLOT**. The vote will be cast by the authorized representatives of a member who shall deposit with the Secretary General his Identity Card indicating his status in the Company.
