The resolution was seconded by Dr. Bakht Jamal of Adamjee Life Assurance Co. Ltd.

The Chairman placed the Resolution before the Members and declared it carried unanimously.

Members advised the Executive Committee to consider formulating a process for inflation adjustment every year or after three years.

With regard to third item of the agenda, Mr. Nasir Ali Syed of 5th Pillar Family Takaful Limited proposed the following Resolution:-

"I, Mr. Nasir Ali Syed of 5th Pillar Family Takaful Limited propose that M/s. RSM Avais Hyder Liaquat Nauman, Chartered Accountants be and are hereby appointed Auditors of the Association to act as auditors of the Association for the year ending 30th June 2026 at a fee to be mutually agreed."

The resolution was seconded by Ms. Huma Waheed of United Insurance Co. of Pakistan Ltd.

There being no comments or questions, the Chairman placed the Resolution before the Members and declared it carried unanimously.
